### **Properties Usage Guidelines**

The mission of the Texas Trails Council Camp Properties Committee is to improve the appearance, sustainability, and value of Camp Billy Gibbons and Camp Tonkawa. In cooperation with the Council staff and other committees, Camp Properties Committee volunteers carry out initiatives in five main areas: Property Administration (plans, policies, budgets), Capital Construction (building projects), Conservation (conservation plans and sustainability), Camp Improvement (maintenance, repairs, and service projects), and Facilities Marketing (off-season Scout use and non-Scout rentals).

### **Camp Tonkawa**



Camp Tonkawa is nestled under huge oak trees in southern Taylor County, Texas. Located about 14 miles south-southwest of Abilene and about 3 miles west of Buffalo Gap, the camp is on FM 89 next to the Abilene State Park. Camp Tonkawa is a camp where the Spirit of Scouting is still strong. Songs, campfires, fellowship, and outdoor adventures make it an excellent Scouting adventure for Scouts of all ages. The camp is also used by many Non-Scouting groups throughout the year such as 4-H, YWCA, Big Brothers / Big Sisters, Hunter Safety Education, and many other local organizations.

### Non-Scout Use of Council Facilities...

It is the policy of the Boy Scouts of America that a Scout camp may be made available on a limited basis to non scouting organizations that have supported Scouting or whose missions are compatible with Scouting, as a service to the community, under the following conditions.

- That it does not interfere with the use of the camp for its intended purposes by the BSA.
- That it does not interfere with Scout usage of the property.
- That the group shall provide qualified adult leadership plus additional trained staff in sufficient numbers to adequately conduct its programs and effectively provide for the safety, health, and wellbeing of all participants.
- That all standards and certifications as may be required by law or in keeping with accepted practices be complied with.
- That there be a definite written <u>Letter of Agreement for Camp Use</u>, properly endorsed by both
  parties, that covers terms of use for the property, including a <u>Release and Indemnity/Hold-Harmless</u>
  <u>Agreement</u> and proof of adequate liability and other insurance coverage as appropriate.
- That preference shall be given to nonprofit organizations.
- That the guidelines found in Texas Trails Council Risk Management Guide, are followed.
